Accessibility Policies and Multi-Year Accessibility Plan

This 2014-2021 accessibility plan outlines the policies and actions that Arnts The Landscape Supplier Inc. will put in place to improve opportunities for people with disabilities.

Statement of Commitment

Arnts The Landscape Supplier Inc. is committed to treating all people in a way that allows them to maintain their dignity and independence. We believe in integration and equal opportunity. We are committed to meeting the needs of people with disabilities in a timely manner, and will do so by preventing and removing barriers to accessibility and meeting accessibility requirements under the Accessibility for Ontarians with Disabilities Act.

Accessible Emergency Information

Arnts The Landscape Supplier Inc. is committed to providing customers and clients with publicly available emergency information in an accessible way upon request. We will also provide employees with disabilities with individualized emergency response information when necessary.

Training

Arnts The Landscape Supplier Inc. will provide training to employees, volunteers and other staff members on Ontario's accessibility laws and on the Human Rights Code as it relates to people with disabilities. Training will be provided in a way that best suits the duties of employees, volunteers and other staff members.

Arnts The Landscape Supplier Inc. will take the following steps to ensure employees are provided with the training needed to meet Ontario's accessible laws by January 1, 2015:

• The required training has been included as a mandatory part of new employee orientation training.

Kiosks

Arnts The Landscape Supplier Inc. will ensure employees consider the needs of people with disabilities when designing, procuring or acquiring self-service kiosks by January 1, 2014.

<u>Information and Communications</u>

Arnts The Landscape Supplier Inc. is committed to meeting the communication needs of people with disabilities. We will consult with people with disabilities to determine their information and communication needs

Arnts The Landscape Supplier Inc. will take the following steps to make all new websites and content on those sites conform with WCAG 2.0, Level A by January 1, 2014:

- All new Arnts The Landscape Supplier Inc. websites are assessed and evaluated for accessibility to ensure conformance with WCAG 2.0 Level A;
- All Arnts The Landscape Supplier Inc. web content is assessed and evaluated for accessibility conformance.

Arnts The Landscape Supplier Inc. will take the following steps to ensure existing feedback processes are accessible to people with disabilities upon request by January 1, 2015:

• Arnts The Landscape Supplier Inc. customer feedback processes allow for multiple types of communication such as e-mail, telephone, fax or regular mail.

Arnts The Landscape Supplier Inc. will take the following steps to make sure all publicly available information is made accessible upon request by January 1, 2016:

- Arnts The Landscape Supplier Inc. will consult with the person making the request to determine the suitability of the accessible format or communication support;
- Provide or arrange for the provision of accessible formats and communication supports in a timely manner that takes into account the person's accessibility needs due to disability, and at a cost no more than the regular cost charged to other persons;
- Notify the public about the availability of accessible formats and communication supports.

Arnts The Landscape Supplier Inc. will take the following steps to make all websites and content conform with WCAG 2.0, Level AA by October 1, 2021:

- Arnts The Landscape Supplier Inc. will ensure that all websites and web content on the websites conform with WCAG 2.0 Level AA and will be compliant by October 1, 2021.
- Conduct accessibility reviews of all websites prior to launch.

Employment

Arnts The Landscape Supplier Inc. is committed to fair and accessible employment practices. We will take the following steps to notify the public and staff that, when requested, Arnts The Landscape Supplier Inc. will accommodate people with disabilities during the recruitment and assessment processes and when people are hired:

- Review existing policies and procedures and where necessary, adjust processes for people with disabilities;
- Arnts The Landscape Supplier Inc.'s new employee orientation training includes a section on accessibility.

Arnts The Landscape Supplier Inc. will take the following steps to develop and put in place a process for developing individual accommodation plans and return to work policies for employees that have been absent due to a disability:

• Review existing policies and procedures and if necessary, adjust processes for people with disabilities on the development of accommodation plans and return to work processes.

We will take the following steps to ensure the accessibility needs of employees with disabilities are taken into account if Arnts The Landscape Supplier Inc. is using performance management, career development and redeployment processes:

• Review existing policies and procedures and amend when necessary.

Arnts The Landscape Supplier Inc. will take the following steps to prevent and remove other accessibility barriers identified:

• Review existing policies and procedures and amend when necessary.

Design of Public Spaces

Arnts The Landscape Supplier Inc. will meet the Accessibility Standards for the Design of Public Spaces when building or making major modifications to public spaces. Public spaces include:

- Recreational trails / beach access routes
- Outdoor public eating areas like rest stops or picnic areas
- Outdoor place spaces, like playgrounds in provincial parks and local communities
- Outdoor paths of travel, like sidewalks, ramps, stairs, curb ramps, rest areas and accessible pedestrian signals
- Accessible off street parking
- Service-related elements like service counters, fixed queuing lines and waiting areas

In the event of a service disruption, we will notify the public of the service disruption and alternatives available.
