

DISPOSAL SERVICES

WHAT IS ALLOWED TO BE DISPOSED OF AT ARNTS?

Our disposal services are for general landscaping purposes and as such can only be filled with clean fill, concrete or asphalt - these items cannot be mixed.

CLEAN FILL

Consists of materials you would normally dig up as you prepare to install some form of landscape into your property. This includes: sod, soil, roots, and small plants.

- ★ Roots must be pulled out and disposed of in the *brush bin*
- ★ Small plants must be separated and disposed of in the *leaf bin*

BRUSH (Cleanfill charge)

Any roots or branches in your cleanfill disposal must be separated and disposed of in our *brush bin*

LEAF (Cleanfill charge)

Large amounts of leaves must be separated from cleanfill and disposed of in our *leaf bin*

CONCRETE

Consists of cut off brick (including clay bricks), old pavers, aggregate, gravel, etc.

- ★ No soils, clay fill

ASPHALT

Consists of clean asphalt only.

- ★ No brick, concrete or aggregate

If your company is caught disposing of a mixed load or using our bins incorrectly, you will no longer be permitted to use our disposal services.

WHAT IS NOT ALLOWED TO BE DISPOSED OF AT ARNTS?

Non-landscape materials are not allowed in any Arnts landscape disposal bins, this includes but is not limited to:

Batteries	Drywall	Lumber
Blue Box Recyclables	Pesticides	Treated/Regular Wood
Electronics	Propane	Plastics
Chemicals	Cylinders	Fast Food Wrappers
Gasoline	Railroad Ties	Water Bottles
Paint	Refrigerators/Freezers	Tree Stumps
Oil/Oil Filters	Tires	Waste
	Solvents/Flammable Liquids	

If any non-landscape material is disposed of at Arnts the Landscape Supplier Inc, your company will no longer have privileges to use our disposal services. We will not separate materials, the entire load will be considered non landscape material and will need to be cleaned up by your company.

Our team at the drive thru office will be collecting additional information at the time of inspecting the load. We will be asking for the job site of where the material came from, as well as recording the vehicle license plate number. Additional cameras have been installed in the section of the yard where material is dumped, and this area will be heavily monitored.

If your company is caught breaking any of our disposal rules, you will no longer be permitted to dump here.
